SURETY BONDS:

If you have a surety bond, contact your bonding company and request that it be cancelled.

CASH BONDS OR CERTIFICATES OF DEPOSIT:

Cash Bonds or Certificates of Deposit submitted in lieu of a surety bond may be withdrawn two years after the **termination** date of the **Inactive Status** if there are no outstanding claims against them pursuant to A.R.S. §32-1152(D).

If the license has completed the first five year inactivation and is not reinstated or the inactive status is not extended for an additional five years, the Cash Bond or Certificate of Deposit will be held for an additional two years from the date of the expiration of the license.
