### NOTICE OF DISASSOCIATION

**IF THE QUALIFYING PARTY FOR A LICENSE DISASSOCIATES FROM THE LICENSED ENTITY, BOTH THE LICENSEE AND THE QUALIFYING PARTY MUST GIVE WRITTEN NOTICE TO THE REGISTRAR OF CONTRACTORS WITHIN FIFTEEN (15) DAYS AFTER SUCH DISASSOCIATION. (§ 32-1167, A)**

**THE LICENSEE HAS SIXTY (60) DAYS FROM THE DATE OF THE DISASSOCIATION TO HAVE ANOTHER QUALIFIED PERSON PLACED ON THE LICENSE. IF THE LICENSEE FAILS TO HAVE ANOTHER PERSON QUALIFIED WITHIN SIXTY (60) DAYS, THE LICENSE WILL BE AUTOMATICALLY SUSPENDED UNTIL ANOTHER QUALIFIED PERSON IS PLACED ON THE LICENSE. (§ 32-1167, B)**

**THE EFFECTIVE DATE OF THE DISASSOCIATION IS THE DATE THE DISASSOCIATION IS RECEIVED BY REGISTRAR OF CONTRACTORS.**
